Dear Friends,

As summer begins to wind down and we approach September, change is in the air in more than one way. Families are preparing to go back to school or if you're like some of my staff, looking forward to the cooler weather and Fall activities. For us at the Port, Fall means the start of budget season as we work to set the 2023 budget.

I am proud to share that over the last two years, I have been working with leaders from the Port's Finance Team and Change Team to create a new tool for the Port to ensure we are thinking about our budget through an equitable lens. In 2021, we launched the Equity in Budgeting toolkit used by 53 departments. Fast forward to this year, we are using this tool as a part of our budgeting process required for all departments for developing their budget proposals. If budgets are a moral document that shows what we value, this is a concrete action step the Port of Seattle is taking to advance our Century Agenda goals and embed systemic change in how we operate.

The work to shift our culture and systems to one that is inclusive and equitable is critical, and I am grateful to our staff and leaders at the Port of Seattle and partners in our region that are key to advancing the Port's mission of becoming a model of equity, diversity, and inclusion and fostering a culture of belonging in our everyday work.

## Change Team Updates



Two years ago, we created the Port of Seattle's Change Team to help operationalize our values of equity and anti-racism. The Change Team includes representatives from every Port department who lead efforts to implement of equity principles and practices. The Change Team has also been developing best practices and guidance on many of the recommendations from the [2021 Equity Assessment](#) and [Women of Color Assessment](#) through Change Team sub-committees.

Committees are developing toolkits and training courses to shift operations and practices of the Port in order to close the gaps from assessment findings. Change Team committees approach work with an inter-disciplinary approach as individual members bring their expertise and knowledge from the Port's many lines of business and operations. Committees are focused in eight issue areas:

- budget and equity;
- infrastructure and engagement;
- data and equity;
- represented and shift workers;
- training and facilitation;
- tracking and reporting;
- community engagement;
- and hiring.

Towards the end of this year, we look forward to sharing updates about our implementation of assessment recommendations, share the tools created by Change Team committees for a more equitable Port, and the creation of annual, department-specific equity goals.

## Funding Opportunity: South King County Community Impact



Beginning on September 15, community-led groups can apply for Port of Seattle funding to improve the local environment and increase economic opportunities in neighborhoods near SEA Airport. With the launch of the third cycle of the [South King County Community Impact Fund \(SKCCIF\)](#), organizations can apply for either Economic Recovery Funding or Environmental Grants.

To prepare organizations to apply for this funding, Port staff are hosting a series of virtual workshops and in-person site visits focusing on the most important components of the application process and providing interested organizations and individuals with key information.
