Hold Harmless Agreement

In no case shall User be responsible or liable for any defense, claims, loss, or judgments that results from the sole negligence of the Port. The obligations of this paragraph shall not be construed to negate, abridge, or otherwise reduce any other right or obligation which would otherwise exist as to any person or entity described in this paragraph.

User understands that there are risks involved in accessing and utilizing Shilshole Bay Marina for the desired activities of the User; and understands that there may be unknown risks and hazards as well. The User assumes the risk of injury or harm and releases the Port from all liability for injury, illness, and death or property damage resulting from the use Shilshole Bay Marina property for the activities of the User. User agrees to release the Port as well from any liability for injury, illness and death or property damage incurred by invitees and guests of the User.

User grants and conveys to the Port all rights, title and interest in any and all photographic images and video or audio recordings made by the Port during the Users access and stay at Shilshole Bay Marina. User, and any invitees of User, agrees to follow all safety procedures as directed by the Port.
