Seattle Tacoma Air Cargo Association

Constitution

Effective January 1, 1962
As Revised June 1, 1978, September 18, 1979, April 1985, and February 2003

ARTICLE 1 – NAME

The name of this organization shall be the Seattle Tacoma Air Cargo Association

ARTICLE II – PURPOSE

The purpose of the Seattle Tacoma Air Cargo Association is:

1. To identify and to give status to the air cargo industry as a whole and to represent its desires and best interests to the community at large.
2. To promote the exchange of common ideas and problems.
3. To develop a cordial relationship among its members.
4. To present to the members programs of educational value relating to the cargo transportation industry and allied fields.
5. To present to the air cargo industry recommendations for its future development and progress.

ARTICLE III – POLICY

This Association shall not participate in any controversial matter arising between factions within the transportation industry without a three-quarter majority vote of the total active membership.

ARTICLE IV – MEMBERSHIP

There shall be two classes of members as follows:

1. Active memberships shall be as covered in the By-Laws.
2. Honorary membership may be granted to individuals, companies or organizations not actively engaged in the air transportation industry, provided:
 - a. They have rendered or contributed some distinguished service to the air cargo industry.
 - b. They are elected in the manner prescribed in the By-Laws.

ARTICLE V – OFFICERS AND DIRECTORS

Section A The officers of this organization shall be a President, First Vice President, Second Vice President, Third Vice President, Secretary/Treasurer.

Section B The most recent two past presidents and the most recent secretary treasurer and the officers of the association shall constitute the Board of Directors. The Chairman of the Board of Directors shall be the President as elected for the current year. If past officers choose not to serve on the Board of Directors, a majority vote by the departing Board will elect any of the non-officer held positions for the following year.

Section C The primary purpose of the three non-office holding board members shall be to offer advisory support. The officers shall hold primary responsibility for setting the agenda of the club.

Section D The business and affairs of this Association shall be managed and directed by the Board of Directors. The Board of Directors shall be subject to the orders of the Association and none of its acts shall conflict with action taken by the Association.

- Section E Five members of the Board of Directors shall constitute a quorum for the transaction of business.
- Section F The officers and directors of this organization shall perform and discharge such duties as may be prescribed by the By-Laws.
- Section G In case of a vacancy in the office of President, the First Vice President shall succeed in office, upon approval of the Board of Directors. A vacancy in any other office shall be filled in accordance with the By-Laws.
- Section H The Board of Directors shall meet on the second Thursday of June, September, November, February, and May. Officers shall meet at their own discretion.
- Section I Those taking the office of President shall understand they are entering into a three year commitment and those taking the office of Secretary-Treasurer, shall understand they are entering into a two year commitment.

ARTICLE VI – ELECTIONS AND TERMS OF OFFICERS

- Section A. The officers of this organization shall be elected as follows:
 - A nominating committee shall be appointed by the Board of Directors in the month of February of each year, and said Nominating Committee shall make it's report at the meetings in March. Nominations may be made from the floor at the April meeting by any members with the same effect as a nomination for any office made by the Nominating Committee.
 - The term of office shall be for one year from June through June of the following year. Any officer is eligible to serve more than one term in any office except for that of President.
- Section B Ballots will be presented to the membership at the May meeting. These ballots are to be voted upon and returned to the Secretary/Treasurer for audit at the May meeting, and results announced.
- Section C The newly elected officers shall be installed and begin their term of office at the conclusion of the June meeting.
- Section D The person receiving the plurality of votes cast for each elective position shall be declared elected.
- Section E The officers shall begin their terms of office at the conclusion of the annual election meeting in June.

ARTICLE VII – MEETINGS

Meetings shall be held as prescribed in the By-Laws.

ARTICLE VIII – COMMITTEES

Committees may be appointed for special functions as required by the President.

ARTICLE IX – RULES

- Section A This Association shall adopt By-Laws for the government thereof in all matters not provided for by this Constitution and not inconsistent therewith, which By-Laws shall provide the method of their amendment.
- Section B In the absence of special rules, and except as provided by the Constitution and By-Laws, the proceedings of the Association shall be conducted in accordance with Robert's Rules of Order, Revised.

ARTICLE X – AMENDMENTS

This Constitution may be amended at any regular meeting by a two-thirds vote of the members present. All proposals of amendment must be submitted to the Board of Directors and announced in writing to the membership at least one month prior to the meeting at which the vote shall be taken.

ARTICLE XI – VOTING

Voting privileges shall be restricted to active members as defined in Article IV, Subhead 1, with one vote only allowed or each member company.

By-Laws

Effective January 1, 1962

As revised June 1, 1978, September 18, 1979, April 1985, and March 2003

No. 1 – MEMBERS

- Section 1 Membership in this Association shall be open to those interested in the promotion of the air cargo industry.
- Section 2 Members of this Association shall be elected in the following manner:
Proposals for membership may be submitted in writing or from the floor at any regular meeting, and such proposals shall be referred to the Membership Committee for investigation. The member committee will advise the Association members of their action at the next regular meeting of the Association.
- Section 3 Honorary members shall be elected by the recommendation of the Board of Directors and the majority vote of the members present at any regular meeting.

No. 2 – DUES

All membership shall be in the name of the company or individual. The dues amount will be set by the Board of Directors. The dues statements will be issued in September of each year and payable by October 31. A roster shall be published during each January to reflect all current members.

No. 3 – PROGRAM

The program committee shall be chaired by the Second Vice President to provide the program for each regular meeting.

No. 4 – MEETINGS

Meetings shall be held on the third Thursday of each month September through May at a time and place determined by the Board of Directors

No. 5 – DUTIES OF OFFICERS

- Section 1 It shall be the duty of the President to preside at all meetings; be ex-officio member of all committees of the Board any time the President feels it necessary. It will also be the President's responsibility to nominate a member to fill any vacancies on the Board of Directors when they occur, and to appoint that member to the vacancy with the approval of the remaining Board of Directors.
- Section 2 It shall be the duty of the First Vice President, in the absence of the president, to assume his duties and in general assist in the work of the Association. It shall be the duty of the First Vice President to function as Membership Chairman. The First Vice President shall be responsible for promotion of attendance at all meetings and monthly notification of meeting dates and programs to the membership.
- Section 3 It shall be the duty of the Second Vice President to function as Program Chairman and arrange the program for each meeting (with the exception of those meetings held strictly for business) and present plaques to guest speakers. It shall be the duty of the Second Vice President to arrange and handle public relations and attend to monthly news releases.
- Section 4 It shall be the duty of the Third Vice President to serve as Sergeant-at-arms; to take lunch reservations, complete reservation slips (to be used as attendance records) and relay head count and meeting requirements to hotel. To have all members seated in the meeting room by the starting time of the meeting; maintain order during the meeting; assist Secretary/Treasurer on collecting money from members; and present attendance slips to the Secretary before the meeting is adjourned.
- Section 5 It shall be the duty of the Secretary/Treasurer to keep an accurate record of the proceedings of each meeting, be prepared to read on call the record of any business transaction of any previous meeting, attend

to the correspondence of the Association, keep an accurate record of income and disbursement and collect money from members at each meeting for meals and any other assessments.

Section 6 The duties of the Board of Directors shall be as follows:

- (a) It shall be responsible for the execution, through its officers, of the recognized and authorized policies of the Association.
- (b) It shall authorize all expenditures and shall not create indebtedness beyond the income of the Association, nor disburse funds for purposes not essential to the object of the Association.
- (c) A majority vote of the Board of Directors shall govern. It shall have power to overrule or modify the action of any officer of the Association.
- (d) It shall have the books and accounts audited annually and reported at the June meeting, or more often at its discretion.
- (e) It shall hold special meetings when called by the President of the Association, or by written request of five paid up members of the organization.

Section 7 Officers shall be encouraged to participate in one or more outside related clubs or associations for the purpose of promoting the Air Cargo Association.
