- The non-refundable waitlist fee is \$100 for Shilshole Bay Marina and \$25.00 for Harbor Island Marina.** This fee only applies if moorage is not immediately available and your name is placed on a waitlist according to boat size.
- Applicant(s) agrees to keep the marina office advised of any changes in address and telephone numbers.** When moorage becomes available, we will only notify you by mail and telephone. If we are unable to reach you, or if you fail to accept our offer for moorage in a timely manner, you will forfeit the application fee and your name will be removed from the waiting list without further notice.
- Prior to move-in, Port of Seattle requires the first month's rent and security deposit** equal to one month's rent less the leasehold tax to be paid to appropriate marina. Upon receipt of money and signed contract, you will be issued keys and other pertinent information.
- Only the applicant(s) signing this application will have rights to moorage at Port of Seattle marina.** The slip for which you have applied will be for the benefit of the below named/signed applicant(s), his/her spouse/valid domestic partner, and/or minor children. If two or more applicants share an interest in this application at Shilshole Bay Marina all parties must apply for moorage and the signatures and addresses must be shown herein.
- This application only applies to the vessel size and characteristics stated above. If you decide to moor a larger or smaller vessel and want a different size slip, you may submit a Change Request for a fee of \$10.00. Each subsequent change request by the same customer will be \$35.00. Please note the waiting times vary for each slip size.
- If you have no vessel by time of assignment of moorage, you will not be assigned moorage. You must present a current state registration and your vessel must fit the slip in order to be assigned moorage. **It is important that the vessel size listed above remains accurate.**
- Permitted watercraft includes a vessel designed for navigation on open waters, capable of being used as a means of transportation and used for recreational boating, yachting, or commercial fishing. **Houseboats are not allowed.**
