

PORT OF SEATTLE MARINE DIVISION ENVIRONMENTAL SPILL PLAN & PROCEDURES

1.0 Preface

The Port of Seattle Marine Division (Port) is obligated to protect and preserve the natural environmental and employees' health and safety, while ensuring safe and efficient maritime traffic.

In support of this obligation the Port Environmental group is tasked with promoting a quick and effective response to environmental incidents at all Port properties.

The Port Environmental Incident Notification (PEIN) program described in this manual was developed to ensure that Port Environmental staff are prepared to provide incident support.

The definition of an environmental incident is any situation where hazardous materials may threaten life, health, or the environment. (The hazardous nature of materials may be poorly defined in the initial stage of an incident response.)

The definition of a response in this manual is coordinated actions taken (including initial notifications) to counter effects of an environmental incident.

The **primary role of the PEIN** program during an incident response is to:

- Confirm necessary notifications occur in the event that an incident (even potentially) rises to the jurisdiction of federal, state, and/or local authorities.
- Identify an on-scene Incident Contact (or Responsible Party).
- Provide assistance if additional resources are needed.
- Record incident response information.
- Evaluate cause and assess procedures and prevention measures.

The Port Environmental Incident Notification program described in the manual is not intended to take the place of emergency response plans required by WISHA or otherwise conflict with federal, state, or local regulations developed under legal authorities. This plan strives to be compatible with the incident command system as outlined in the *Washington Statewide Master Plan for Oil Spill and Hazardous Substance Release Response*, as adopted from 2013 USCG/EPA Northwest Area Contingency Plan.

The PEIN program is not intended to replace the good judgment of a spill responder in the safe operation of a response. However, it should provide guidance on how to proceed. In the event of a spill to land or water, utilize the following contact sheet.

Port of Seattle Illicit Discharge Notification Handout

In the event of a non-stormwater discharge to surface water or stormwater infrastructure (catch basin, drainage ditch, pipe, etc), proper agencies must be notified, following the steps below.

- 1. Be prepared to provide the following information:
 - Where is the discharge?
 - What was released?
 - How much was discharged?
 - Who is responsible?
 - Is anyone cleaning up the discharge?
- 2. Make notification calls to:
