**New fast charging EV stations at SEA Cell Phone Lot help reduce carbon emissions**

SEA is now a destination along the West Coast Electric Highway with two new fast charging electric vehicle (EV) stations capable of serving four EVs at a time.

A new public-private partnership between the Port of Seattle, Washington State Department of Transportation (WSDOT), Forth, and EVgo made the charging stations

possible. The EV stations meet Port values for supporting healthier communities and the environment and make it easier for airport customers to reduce pollution and embrace sustainability.

The two fast chargers, located in the Cell Phone Lot, augment the airport's portfolio of 54 charging stations already installed in the parking garage.

Starting Oct. 1, 2020, travelers 18 years and older will need a REAL ID-compliant form of identification to board a commercial flight.

Congress passed The REAL ID Act in 2005, which established minimum security standards for state-issued driver licenses and identification cards. The Act further prohibited federal agencies, including the TSA, from accepting state-issued driver licenses or identification cards that do not meet the minimum standards.

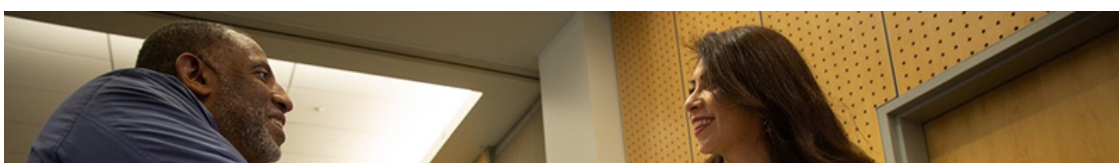

### Salmon-Safe recognizes Port's work to improve Puget Sound water quality

Port of Seattle's maritime parks and public access areas earned a "Salmon-Safe" recertification this year, recognizing efforts to enhance the ecological environment and restore salmon habitat.

Since 2008, the Port has earned this certification by demonstrating its commitment to protect the Puget Sound water quality by enhancing the ecological environment and restoring salmon habitat. The Salmon-Safe certification is a comprehensive third-party evaluation program that involves continuous improvement and reassessment every five years. Since its last certification, the Port has further reduced use of fertilizers,



implemented a water conservation plan, assessed additional system-wide opportunities for stormwater treatment and habitat restoration, and installed stormwater treatment and habitat restoration projects on a number of Port properties.

## Restoring urban forests in airport communities



Volunteers “got their green on” at Angle Lake Park Nature Trail in the City of SeaTac recently as they kicked off the first in a series of three planting events sponsored by the Port of Seattle. Led by non-profit Forterra and in close coordination with the city of SeaTac, 25 volunteers planted over 200 native trees, shrubs, and ground cover along the shore of Angle Lake.

These events are a turning point in a multi-year collaborative project to involve communities near the airport (Burien, Des Moines, and SeaTac) in [Forterra's Green City Partnerships program](#). The program was created with the philosophy that healthy forested parks and green spaces have the power to strengthen neighborhoods, provide safe access to nature, and offer many valuable benefits to the environment.
