



The Lander Street Bridge is now complete, diverting traffic from other crowded terminal corridors over the railroad tracks between 1st Avenue S and 4th Avenue S. # SEA steps on the (renewable) gas to halve carbon emissions



SEA is accelerating towards the Port's goals to reduce carbon emissions. This month we became the first airport in the country to purchase thermal renewable natural gas (RNG), a low-carbon natural gas alternative produced from landfill waste, to heat the airport terminal. Switching from higher carbon fossil fuel to renewable waste-derived fuel will enable the Port to reduce its carbon emissions by 50 percent in 2021. Keep Reading →
