WHEREAS, The County and the Port are interested in examining the feasibility of consolidating management of King County International Airport in the Port of Seattle or other appropriate regional agency, and

WHEREAS, the Port has agreed to undertake the lead role in contracting for and preparing the Interlocal Agreement, and

WHEREAS, the County is interested in evaluating the advantages and disadvantages of such consolidation and desires to contribute to the cost of the Interlocal Agreement.

NOW THEREFORE, BE IT RESOLVED by the Port Commission of the Port of Seattle that:

- The Executive Director of the Port of Seattle is hereby authorized to execute said Interlocal Agreement in substantially the form attached hereto as Exhibit "A" and by this reference incorporated herein.
- 2. The Executive Director is hereby authorized to hire consultants to carry out the project tasks, subject to budget constraints.
- 3. A copy of the final executed Interlocal Agreement shall be attached to this resolution as Exhibit "B".



## INTERLOCAL AGREEMENT

## Consolidation of King County International Airport in the Port of Seattle

This Agreement is entered into this \_\_\_\_\_ day of \_\_\_\_\_, 1990, between King County, hereafter referred to as "County", and The Port of Seattle, hereafter referred to as "Port".

WHEREAS, the County and the Port are interested in examining the feasibility of consolidating management of King County International Airport in the Port of Seattle or other appropriate regional agency, and

WHEREAS, the Port has agreed to undertake the lead role in contracting for and preparing the feasibility study, and

WHEREAS, the County is interested in evaluating the advantages and disadvantages of such consolidation and desires to contribute to the cost of the feasibility study.

NOW THEREFORE, in consideration of mutual benefits, the County and the Port agree as follows:

1. The Port shall undertake the study and shall act as lead agent and contracting authority for the study as described in the attached Request for Qualifications and in the Scope of Work attached thereto as Attachment A.

2. The County agrees to reimburse the Port for one half of the total costs of contracting for the study, in an amount not to exceed \$25,000. The Port shall bear all costs in excess of a total \$50,000, unless the County has agreed in writing to share such excess costs. Reimbursement requests will be presented to the County with adequate documentation and the County agrees to review and act on each request for payment within 30 days of receipt of each payment request.

3. The Port shall consult regularly with the County on the progress of the preparation of the study. Four copies of a final report shall be submitted to the County within 30 days of completion of the study

4. No liability shall attach to the County or to the Port by reason of entering into this Agreement except as expressly provided herein.

5. The Port shall be deemed an independent contractor for all purposes and the employees of the Port, or any of its contractors, subcontractors and the employees shall not in any manner be deemed to be employees or agents of the County.

6. The Port and the County shall each provide sufficient staff support and access to data to permit the consultant to carry out the work activities described in the above-referenced Scope of Work.

This Agreement shall be effective upon execution, and shall terminate when the obligations hereunder have been completed or December 31, 1990, whichever is earlier.

## SCOPE OF WORK

#### CONSOLIDATION OF KING COUNTY AIRPORT IN THE PORT OF SEATTLE

#### Assess the Finances and Operations

#### Α. Inventory Financial and Operational Data

Work with the staffs of the Port, the County, and key tenants, as appropriate, to obtain and organize current revenue and expense budget data for King County Airport and up to three years of historical financial, statistical, and operating data, including:

- 1. Airport lesse maps and building layout plans denoting the location of current tenants.
- 2. Environs maps denoting tenents and land uses in the areas surrounding the airport, particularly within areas affected by airport noise.
- 3.
- Summaries of important leases and agreements. Summaries of important management, maintenance, and service 4. contracts
- 5. Airport master plans and capital improvement programs
- Other recent studies pertaining to airport operations, noise 6. mitigation programs, etc.
- 7 Organization structure and staffing
- 8. Operating expenses by object and subobject category
- Operating revenues by source and by tenant 9.
- 10. Fee structures for services provided at the airport
- 11. Services provided by the County, including those charged and not charged to the airport
- 12. Debt obligations and debt service schedules
- 13. Airport traffic statistics, including aircraft operations,

Particular attention would be given to documenting the provision of services at the airport, including who provides them and their costs, whether or not they are now separately identified or charged. We would also identify services not currently provided that might be required after consolidation.

B. <u>Present Alternatives for the Role of the Airport in the Regional</u> <u>Airport System</u>

In conjunction with the Flight Plan project, suggest changes in the activities at King County Airport to complement regional air transportation needs Include analysis of ground transportation linkage and access issues affecting role.

#### III. Review Capital Improvement Program, Assess Capital Development Financing and Consolidation

## A. <u>Review the Status of Ongoing and Proposed Capital Improvement and</u> <u>Noise Mitigation Projects and Plans</u>

Identify on- and off-airport capital improvement and noise costs relating to the alternative uses of King County Airport suggested in Task II.B. Summarize projects and costs for a three- to five-year period reflecting the priority of projects. Assess the sources and uses of funds for financing the capital program as part of the Port, including the potential for federal grants-in-aid

B. Review Proposals for the Terms of Consolidation

On the basis of discussions with Port and County officials, identify the general terms of a transfer agreement for the airport, including financial support; transfer of land, facilities, assets, and personnel; transfer of debt; provision of administrative or overhead services; and relations with Boeing and other major tenants

C. Prepare Pro Forma Financial Plan

On the basis of the finding in the above tasks, prepare a pro forma financial plan for King County Airport, incorporating projections of revenues, operating expenses, debt service, and overall cash flow. Assess the potential for self-supporting operations, the need (if any) for financial support by the Port, and comment on opportunities for increasing revenues and reducing operating expenses to strengthen the airport's financial position

## IV. Presentation of Findings

#### A. <u>Prepare Study Report</u> Prepare a report in draft form summarizing the findings of the tasks described above.

- B. <u>Present Findings in Draft Form</u> Present draft report to a joint Port/King County working committee Incorporate any revisions into the report suggested by the committee. Present the revised draft report at a public meeting of airport tenants and the interested public. Incorporate any revisions.
- C. <u>Present Final Findings</u> Write final report and present findings to Port Commission and King County Council.
