## RESOLUTION of the Port Commission of the Port of Seattle authorizing the sale by public auction of abandoned vessels as provided by RCW 53.08.320 and authorizing the Executive Director and his designees to conduct the sale of future abandoned vessels in its possession when such vessels are the subject of delinquent charges.
