WHEREAS, the Port of Seattle owns the personal property described in Exhibit "A", a copy of which is attached and incorporated herein by reference; and




NOW, THEREFORE, be it hereby resolved by the Port Commissioners of the Port of Seattle that the personal and abandoned property described below is no longer needed for district purposes, and that it is in the best interests of said district that said property be declared surplus and sold or disposed of as provided by statute.
