Persons other than tenants, lessees, permittees with approved contracts, and concessionaires may engage in lawful solicitation of funds for protected religious and free speech purposes while wearing a valid solici-			
tation badge issued hereunder. Persons issued badges shall confine their activities to those areas permitted by paragraph 20. The Police Department shall issue eight (8) such badges beginning at 12:01 a.m. each day, on a first-come, first-served basis. Each badge shall be valid for the 24-hour period beginning at 12:01 a.m. on day of issue. Badges shall be issued and reissued under the following procedures:

GENERAL RULES AND REGULATIONS, continued

- (3) If more persons requesting the issuance of a badge are present, at any time, than the number of badges available at that time, the Police Department shall randomly select the persons to whom badges shall be issued. Such random selection shall be done without regard to the identity of the persons requesting badges or the nature of the First Amendment solicitation activity they wish to pursue.
- (4) Each persons receiving a badge shall return the badge upon completion of solicitation to the Police Department. The Police Department shall, upon request, reissue each badge that is returned.
- (5) The Police Department shall record the information stated pursuant to paragraph 8.b.(2), and also record the date, the badge number, and the times of issue and return. This information shall be available to the general public for inspection upon request.
- c. Persons wishing to engage in lawful solicitation of funds as provided by paragraph 8.b. may, at their option, use solicitation booths, and store, display and distribute materials used in connection with solicitation at such booths, under the following terms and conditions:
 - (1) Persons wishing to use a solicitation booth shall build the booth at their own expense, and may place the booth in the main terminal building only at the locations shown on the diagram outlined on Page 3-3b, on a first-côme, first-served basis.
 - (2) The maximum size of each solicitation booth shall be 4'x5'x6' in height.
 - (3) The design of solicitation booths shall be subject to advance approval of the Director in order to assure that they are consistent with the architectural and aesthetic standards of the airport. The Director shall not arbitrarily withhold approval.
 - (4) Each booth shall be for the sole use of the persons owning it, or persons using it with the permission of the owner.
 - (5) Persons wishing to use a solicitation booth shall request that the Police Department issue them solicitation badges marked with the word "booth" and the name of the owner of the booth. Badges so marked are hereafter referred to as "booth permits." Persons with booth permits may solicit only from within the designated booth or behind it.

- (6) Solicitation booths may be used only when one or more solicitors at the booth wears a valid booth permit. Persons wearing non-booth solicitation permits may solicit from a booth provided that at least one person soliciting from that booth has been issued a valid booth solicitation permit.
- (7) Upon issuance of the first booth permit, the total number of badges available for issue shall be further reduced by two.
- (8) Any person holding a booth permit may exchange the permit with any person holding a solicitation badge.
- (9) All persons engaged in speech activities at the booth and all persons who seek to bring members of the public to the booths shall obtain solicitation badges.
- (10) The Director shall have the right, at the airport's expense, to disassemble and remove any booth for which a booth permit has not been issued for seven (7) days or more.
- (11) The Director shall have the right to sell or otherwise dispose of any booth left in storage for thirty (30) days or more.
- (12) No group or organization, or members of the same group or organization, may simultaneously operate more than one booth.
- (13) The terms of this paragraph 8.c. shall be applicable to the extent that they may be inconsistent with any other provisions of paragraphs 8 and 20.
