RESOLUTION NO. 2573

A RESOLUTION of the Port Commission of the Port of Seattle amending
Resolution No. 2399, adopted December 14, 1971, establishing
a Port of Seattle Police Department, redesignating the Sea-Tac
International Airport Police Department and Commissioning
officers with full police powers.

WHEREAS, the Port Commission of the Port of Seattle, by Resolution No. 2399, adopted December 14, 1971, established a Sea-Tac International Airport Police Department pursuant to RCW 14.08.120 (2); and

WHEREAS, Chapter 62 Washington Laws, 1974 1st. Ex. Sess., authorizes any port district operating an airport with a police department pursuant to RCW 14.08.120 (2) to appoint police officers with full police powers to enforce all applicable federal, state, or municipal statutes, rules, regulations, or ordinances upon any port-owned or operated properties or operations; and

WHEREAS, the Port of Seattle comprises more than 3,000 acres situated in King County, Washington, and represents an investment in terminal buildings, landing facilities, utilities and related improvements of approximately \$382,588,453; and

WHEREAS, the protection of life and property is a desired goal of the Port of Seattle;

NOW, THEREFORE, BE IT RESOLVED by the Port Commission of the Port of Seattle as follows:

Section 1. Effective March 25, 1975 the Sea-Tac International Airport Police Department, as established by Resolution No. 2399, shall be redesignated "Port of Seattle Police Department."

Section 2. The Port of Seattle Police Department is created to enforce all applicable federal, state, or municipal statutes, rules, regulations, or ordinance upon any port-owned or operated properties or operations in accordance with Chapter 62 Washington Laws, 1974 1st Ex. Sess., as now or may

hereafter be amended. Such law enforcement activity shall be for the purpose of preserving the peace, protecting property and human life and to ensure safe public enjoyment of Port of Seattle properties. The jurisdiction of said department shall be restricted to port-owned or operated properties or operations.

Section 3. Only commissioned officers of the Port of Seattle

Police Department shall be authorized to make arrests and otherwise enforce

regulations, ordinances or laws as provided herein on behalf of the Port of

Seattle. Said commissions shall be granted pursuant to the following standards

and regulations:

- (A) The officers named in the attached Appendix A, which is by this reference incorporated herein and made a part hereof, are hereby declared to be commissioned as officers of said force at the ranks shown in said Appendix A, which ranks may change from time to time;
- (B) Additional officers may be commissioned or promoted in rank when the Port Commission has authorized the position to be filled, or when there is a vacancy in the previously authorized position created by the Port Commission, and when the appointee meets the minimum standards of such position as may then be applicable including any probationary period which may apply;
- (C) Commissioned officers shall receive a Certificate of Commission which shall be signed by the Chief of the Department and countersigned by the Director of Aviation: Provided, however, that the Commission for Chief of the Department shall be signed by the Director of Aviation and countersigned by the General Manager; and
- (D) Commissions may be revoked by the issuing authorities if the officers' employment with the Port is discontinued, and may be suspended during leaves of absence for disciplinary purposes, or for failure to meet standards of employment for Port employees.

Section 4. The Director of Aviation in cooperation with the Personnel Director and the Chief of the Department shall be responsible for developing a training program for all commissioned officers; PROVIDED, that police officers must have successfully graduated from a recognized professional police academy or training institution. Such program shall include, not only an initial program of qualification during a period of probation, but shall also include an ongoing training program to assure the highest standards of qualification on a continuing basis for all commissioned officers of the Port of Seattle Police Department. The Director of Aviation in cooperation with the Director of Personnel and the Chief shall also establish such necessary rules of discipline and health standards as may be appropriate and shall specify a standard uniform of dress. Training program, rules of conduct and discipline and standards of health shall generally follow accepted programs, rules and standards applicable to law enforcement agencies in the State of Washington.

Section 5. In the enforcement of all regulations, laws and ordinances on port properties, the Port of Seattle Police Department shall cooperate in all respects with other law enforcement agencies and the Courts to efficiently provide the highest standards of professional law enforcement. The General Manager shall be authorized on behalf of the Port to enter into contracts of cooperation with other law enforcement agencies or organizations of law enforcement agencies for mutual aid, training, special investigative services, communications and record systems for the Port of Seattle Police Department. Such contracts shall be subject to all usual budgetary and financial expenditure control of the Port Commission. The General Manager shall also procure necessary fidelity bonds and false arrest insurance coverage for commissioned officers as may be appropriate.

Section 6. The Director of Aviation with the approval of the General Manager may authorize the issuance of special commissions in the Port of Seattle Police Department to full time law enforcement officers of



Federal, State, or local law enforcement agencies when those officers are assigned to details operating on Port of Seattle property (i.e. narcotics, theft of interstate property, etc.). No commissions shall be issued to any person who is not a full time trained law enforcement officer.

Section 7. Resolution No. 2399, adopted December 14, 1971, is hereby amended for purposes stated herein and in the event of any inconsistencies with the terms and conditions stated herein is hereby superseded.
