

RESOLUTION NO. 2221

A RESOLUTION of the Port Commission of the Port of Seattle providing for the acquisition of additional lands for the location and construction of an additional runway for the landing and taking off of aircraft and for related facilities.

WHEREAS, the Port of Seattle as the owner and operator of the Seattle-Tacoma International Airport is confronted with increased demands for an additional runway for the landing and taking off of aircraft and for related facilities including among others, additional clear zone, taxi-ways, roadway, utility extensions and for land upon which to locate and construct these facilities and improvements; and

WHEREAS, public convenience and necessity, and the preservation of the peace, security and safety of the people of the Port of Seattle and of the State of Washington demand that the hereinafter described parcels of land be acquired for the location and construction of an additional runway for the landing and taking off of aircraft and for related facilities at the Seattle-Tacoma International Airport; and

WHEREAS, the acquisition and development of the properties and facilities hereinafter described have been incorporated into the comprehensive scheme of land development by the Commissioners of the Port of Seattle by Resolution No. 2220, and the funds necessary for the acquisition of said lands and development thereof are now available; and

WHEREAS, the Port of Seattle has the power under and by virtue of the constitution and the laws of the State of Washington and particularly the laws of 1945, Chapter 182, and the

amendments thereto, to acquire lands necessary in the development, ownership and operation of the airport including the location and construction of an additional runway for the landing and taking off of aircraft and for related facilities in connection with the ownership of the Seattle-Tacoma International Airport;

NOW, THEREFORE, BE IT RESOLVED that the Port of Seattle shall acquire by purchase and/or eminent domain proceedings certain real property in the County of King, State of Washington described in Port of Seattle Resolution No. 2220 as Parcels A, B and C and further designated on Port of Seattle Drawing No. 355-2-66A entitled "1966 Comprehensive Scheme Amendment Unit No. 18" and Drawing No. 355-1366 entitled "Parallel Runway Property Acquisition Plan", and more particularly described in Exhibit 1 attached hereto and by this reference incorporated herein.

BE IT FURTHER RESOLVED, that the acquisition of said property is for a public use and purpose, to-wit: for an additional runway for the landing and taking off of aircraft and for related facilities including among others, additional clear zone, taxi-ways, roadway, utility extension and for land upon which to locate and construct said additional runway and related facilities.

BE IT FURTHER RESOLVED, that the acquisition of said property is for public convenience and necessity and for the peace, security and safety of the people of the Port of Seattle and this State.

BE IT FURTHER RESOLVED, that Bogle, Gates, Dobrin, Wickfield & Long, attorneys for the Port of Seattle, be and

they are hereby authorized and directed to being and prosecute actions and proceedings in the manner provided for by law to condemn, take, damage and appropriate the lands and other property necessary to carry out the provisions of this resolution.

ADOPTED by the Port Commission of the Port of Seattle at regular meeting thereof held this 28th day of June 1966, duly authenticated in open session by the signatures of the Commissioners voting in favor thereof and the seal of the Commission.
