

- 24/7 Employee Parking transit operation



Scope Overview

- Code required monument sign modifications
- Replacement of vehicle gate
- Expansion of electric vehicle parking utilizing existing infrastructure
- Replacement of Electrical Feeders


Chiller Panel Replacement Project Phase 2

Central Mechanical Plant (CMP)

Equipment in CMP provides cooling for the entire Airport





Project Purpose

• Replace chiller control panels in the central mechanical plant at STIA to provide an updated visual control screen, more reliability, updated software, and utilize parts that are readily available for future service issues.



There are a total of 8
 Chillers in the Central
 Mechanical Plant. Others
 were replaced in Phase 1



Project Scope

 Remove and replace the integrated control panels for five (5) chiller units in the Central Mechanical Plant (CMP)



 One of the machines that produces chilled water at 42F.



Control Panel operates each individual chiller



Project Scope

- Replacement of existing panelboards, motor control centers, switchboards, feeders, meters, and transformers
- Installation of new electrical closets for relocated panels
- Installation of a new electrical room in Concourse D
- Upgrade fire protection & HVAC systems as necessary to support electrical equipment
- Will include ECCM procurement


Acceleration Motion

Commission passed Motion 2020-4: Acceleration of Sound Insulation Programs at the Port on February 25, 2020.

- Port of Seattle Executive Director shall take necessary actions to <u>accelerate the</u> <u>airport Sound Insulation Program to complete by 2026.</u>
- The Executive Director shall implement the recommended structure, staffing, funding, resources, consulting, and contracting to ensure a timely delivery of the program.

Sound Insulation Program Scope

Continuation of Single-Family Sound Insulation

 80 of 140 eligible homes anticipated to participate in the program

Villa Enzian Condominium is currently participating in the Program

- 28 units
- Advertise for bid Q3, Design Bid Build
- Construction contract award Q4
- Roughly 1 year for construction

Apartments

- 18 complexes comprising 903 apartment units
- Located in Burien, Des Moines, and SeaTac
- Construction Q1 2022 Q3 2027

Places of Worship

- 7 potentially eligible structures in Burien and Des Moines
- Plan to begin design for first project Q3 2023

Future Voluntary Acquisition- Approach Transition Zone (ATZ)

- ATZ is 2,500 feet off the end of the Runway Protection Zone
- ATZ Program is voluntary, no relocations
- 2 single-family homes and 1 apartment building currently identified
- Estimated to begin program Q1 2023

- Varied approach: letter, postcard, adjust messaging


