#### Analysis:

### Step one (26.45c)

- \* We utilized the Disparity Study that was conducted in 2019 and We identified the availability of DBE and non-DBE firms who are ready, willing and able to compete for federally funded contracts that will be solicited by the Port of Seattle. The Port spends the majority of construction dollars with firms located in King County, Pierce County and Snohomish County. We have determined our market area to be the State of Washington. The data sources were narrowly tailored to include the State of Washington Office of Minority and Women's Business Enterprise and the United States Census Bureau Data 2020 Business Patterns of King, Pierce and Snohomish County in Washington.
- \*\* After calculating a base figure of the relative availability of DBEs, we average the based figure for FY 2023-2025 to arrive at an overall goal of **25**%

### Step 2 (26.45d)

We did not consider the median of our past participation of DBEs on projects which was 9.96% for race-conscious.

### **Contract Goals**

The recipient will use contract goals to meet any portion of the overall goal that the recipient does not project being able to meet using RN means. Contract goals are established so that, over the period to which the overall goal applies, they will cumulatively result in meeting any portion of the recipient's overall goal that is not projected to be met through the use of RN means.

The recipient will establish contract goals only on those DOT-assisted contracts that have subcontracting possibilities. It need not establish a contract goal on every such contract, and the size of the contract goals will be adapted to the circumstances of each such contract (e.g., type and location of work and availability of DBE's to perform the particular type of work).
