

Passport Parking Program – Terms and Conditions

Please read carefully. This document discloses the responsibilities that accompany a Passport Parking access card. Failure to comply with these Terms and Conditions may result in suspension, revocation, and/or termination of your Passport Parking membership.

Disclaimer

The Port of Seattle/Seattle-Tacoma International Airport (“The Port of Seattle”) does not take custody or possession of vehicles and accepts NO RESPONSIBILITY for loss or damage to vehicles, accessories or the contents thereof caused by fire, theft, collision, water or any other cause whatsoever.

Access

The access card allows unlimited in and out access to the Terminal Direct (floor 4) level of the airport parking garage each month. Card holders may also access General Parking (floors 1-3, 5-8) with their card. No minimum stay or reservation is required.

Billing

The applicant authorizes the Port of Seattle to automatically charge the applicable fee of \$425 per month, inclusive of all taxes and fees, to the credit/debit card given on their application form, on or about the first day of each month until the applicant cancels in accordance with these Terms and Conditions. The first month of enrollment will be prorated if enrollment is after the first day of the month. Cardholder must maintain an active credit/debit card on file or account will be canceled without notice. Visa, MasterCard or American Express cards are accepted.

Transferability

The applicant is permitted to transfer the card to others for use; however, only one access card will be issued per applicant. The access card may be used for parking only one vehicle at a time. The applicant is responsible for payment of all charges and fees to credit card given on application form resulting from the use of the access card by any person, whether or not authorized.

Cancellation

The applicant must request cancellation prior to the first business day of the month, and can do so by contacting the Parking Office. The Port of Seattle reserves the right to cancel misused access cards at any time without notice.

Lost, Damaged or Stolen Access Cards

A \$25 fee will apply to replace lost, damaged, or stolen access cards. Applicant must contact the Parking Office so the card can be deactivated.

Early Termination Fee

The applicant will be charged a \$50 cancellation fee to the credit card given on their application form if membership is canceled within 90 days of the “start date” on the application form.

Terms and Conditions, continued

Corporate Customers

If you are entering into these Terms and Conditions on behalf of a corporation to obtain a Passport Parking membership for one or more individual parkers, you represent and warrant to us that you are an authorized signatory for that corporation. You agree to provide a copy of these Terms and Conditions and take steps to ensure that your parkers are aware of, and agree to abide by, the terms of these Terms and Conditions, other than those regarding fees being paid by the corporation on the parker's behalf.

Commercial Use

The cardholder is prohibited from the sale, rental, transfer or otherwise making available to third parties the access card for valuable consideration. Passport Parking is intended for the use of the general traveling public and is not to be used for commercial purposes at any time. The bond financing for the SEA Airport garage disallows the operating of private enterprises within the garage.

Indemnification

You agree to indemnify the Port of Seattle and hold it harmless, from and against any and all losses, costs, expenses, damages, or liability relating to, arising from or as a result of your member in the program and/or the use of performance of the program card.

Compliance

Cardholder or Account Manager must maintain an active email address with the airport parking office. Failure to do so may result in membership cancellation without notice. Vehicles parked contrary to signs or pavement markings, or other than in designated parking spaces (i.e. drive aisles, ramps, etc.) will be towed at the owner's expense. Vehicles parked 30 days or more without special arrangements may be impounded and disposed of in accordance with appropriate state laws.

Modification

Parking fees are subject to change as determined by the Port of Seattle giving 30 days notice of the change. These changes may include, without limitation, a change to any existing fees or imposition of new fees. All applications are subject to approval by the Port of Seattle. These parking Terms and Conditions are subject to change without notice.

Privacy Policy

The current terms of our Privacy Policy govern our collection, use and disclosure of your personal information and are hereby incorporated into this agreement. You consent to the collection and use of your personal information for the purpose of facilitating parking transaction with you, to allow us to verify your identity and to contact and communicate with you as an account holder. The Port of Seattle will protect and maintain your personal information and will not sell or rent your personal information to third parties.
