### Port To Contribute \$5.5 Million for East Marginal Way Makeover



The critical East Marginal Way corridor is set to begin a makeover that will deliver a better road along with a much safer bike lane in each direction. Recently, the Port of Seattle Commission approved \$5.5 million to the North Segment of the project in the form of a memorandum of understanding with the City of Seattle. The City's construction will begin this year and is estimated to be complete in 2025.

### Port Commission Approves \$3.9 Million for Equitable Recovery Investments



The Port Commission is expanding its investments in critical equitable recovery programs with the approval of \$3.9 million in funding for youth jobs and local economic development. The Commission approved \$2.1 million to fund the Youth Career Launch Program, an evolution of the Port's Opportunity Youth Initiative, for three years. The Commission authorized \$1.86 million for the Economic Development Partnership program, which supports two-year economic development projects jointly funded by the Port and King County cities. The Commission

also authorized the Executive Director to use underutilized grant program funding from 2021 to support regional small business recovery initiatives.

# Port and Partners Provide Warm and Safe Welcome to Arriving Refugees



Eighteen organizations serving communities around SEA Airport are the recipients of environmental grants in the second round of funding under the Port's South King County Community Impact Fund. The Port awarded \$687,000 to support public improvement projects in Burien, Des Moines, Federal Way, Normandy Park, SeaTac, and Tukwila. Community-led projects include urban forest restoration, park trails maintenance, youth environmental stewardship, community garden improvements, and installation of a public bicycle skills track.


