

RECAP JULY 12: The Port Commission issued a proclamation aligning Port Policing Policy with Washington State Governor Jay Inslee's Directive prohibiting cooperation or assistance with out-ofstate abortion and other reproductive health care investigations, prosecutions, or other legal actions, and reviewed a Bringing Access Equity to the Port's Website report and a Maritime Blue Annual Report.
