



SEPA MITIGATED DETERMINATION OF NON-SIGNIFICANCE (MDNS) OF PROPOSED ACTION

Seattle-Tacoma International Airport (SEA) Snow Storage Expansion

Description of Proposed Project Action: The purpose of the Snow Storage Expansion (herein Project) is to designate additional snow storage area that will provide needed capacity during large snow events and allow SEA to meet the terms of their National Pollutant Discharge Elimination System (NPDES) permit during typical winter snow events.

The Project includes expansion of the two existing snow storage areas, construction of a new snow storage area, and adjacent roadway improvements to accommodate large snow equipment.

Location of Proposed Action: The project will occur within Seattle-Tacoma International Airport's Airport Operating Area. The physical address is:

Lead Agency: Port of Seattle (SEPA File Number 22-01)

Determination: The Port of Seattle has completed an environmental evaluation including review of the proposed Snow Storage Expansion project, including review of pertinent and available environmental information, following the provisions of the Washington State Environmental Policy Act (SEPA) under Chapter 43.21C, Revised Code of Washington (RCW), Chapter 197-11, Washington Administrative Code (WAC), and Port Commission Resolution 3650, Port of Seattle SEPA Policies and Procedures.

On September 12, 2022 as lead agency, the Port of Seattle determined the proposed project would not have a probable significant adverse impact on the environment. Therefore, an Environmental Impact Statement (EIS) is not required under RCW 43.21C.030(2)(c). Any action to set aside, enjoin, review, or otherwise challenge such action on the grounds of noncompliance with the provisions of Chapter 43.21C RCW (State Environmental Policy Act) shall be commenced within 21 days from the date of last newspaper publication of the notice or be barred. Port Commission Resolution 3650 contains the procedures for appealing a SEPA decision of the Port of Seattle.



The Port will accept public and agency comments until 4:00 PM on September 29, 2022.
