Speaking Out Against Hatred



Dear Friends,

For many of us, including myself, the past several weeks have been incredibly challenging, scary, and uncertain. The ongoing conflict in Gaza is horrifying and complicated, especially for those of us with familial and cultural ties to the area.

Many organizations, including the Port, have been at a loss for what to do or say. We have been trying to balance the incredibly complex history and

politics with the recognition and understanding that some of our employees are hurting and suffering. Within our organization, we may not be able to agree on the right way to resolve the conflict in Gaza, but we can find agreement in the values of respect, peace, and safety.

Earlier this week, the Port Commission shared a statement with all Port employees, condemning the rise of antisemitism and Islamophobia, calling on all of us to create a culture of inclusion and belonging in the workplace, and calling for an end of all violence for Israelis and Palestinians, all global citizens, and the communities the Port serve. Below is an excerpt from this message.

We unequivocally hope for peace, justice, and an end to the violence. We wish for a world with lasting peace for Israelis and Palestinians, for all global citizens, and for all the communities we serve.

We condemn the rise in antisemitism, Islamophobia, and anti-Arab racism since the start of the conflict that has caused members of the Jewish and Muslim faiths to experience targeted violence, intimidation, and worse across the U.S. and world. Hate and bigotry should have no home anywhere, and especially in our workplace.

We, commissioners, are acutely aware of the immense pain, fear, and worry that many people in our Port communities – including our view.data.portseattle.org/?qs=680d4133a739b4f0ec5b7481006aaf6e7849bbac8c1f9678c511ff951d299435d6d685dd26e06d47aa...

employees – are feeling as a result of the conflict between Israel and Hamas. While Israeli-Palestinian relations are complex and generations old, we hope deeply for a resolution to the current conflict and a long-term outcome that creates an environment of respect, peace, and safety for all.

We value all of our employees, and we call on our organization to be a model of unity, respect, and inclusion. We want our employees and community members to feel that they belong.




Centering Equity and Taking Action
