## Partner with the Port, Invest in Your Community



Dear Friends,

In 2019, the Port established the [South King County Community Impact Fund](#) (SKCCIF) to foster community partnerships by providing resources and support to historically underserved, ethnically and culturally diverse near-airport communities. From 2020 to 2024, SKCCIF funded four cycles of the [Economic Recovery](#) (now Economic Opportunities for Communities) and Environmental Grants (now the Environmental Improvement) programs. These

programs supported community-led projects that create pathways to training and well-paying jobs and environmental improvements of public spaces. Since the fund's inception, more than 50 organizations have received a total of \$9.25 million, funding over 80 projects.

SKCCIF's Economic Opportunities for Communities (EOC) program [is currently accepting applications](#) (until April 10, 2025) from community-based organizations working to increase economic opportunities in structurally excluded communities that surround Seattle-Tacoma International Airport (SEA) and South King County, extending up to Beacon Hill and the Duwamish Valley. Approximately \$2 million is available in this cycle. Organizations can apply for up to \$115,000 for a single year of funding and up to \$275,000 for multiyear funding (up to 3 years). The EOC Program connects structurally excluded communities near the airport to opportunities for living wage jobs and careers in port-related industries. Funding supports community-led career-prep programs and services that create awareness and access for the next generation of professionals to enter the workforce in aviation, construction trades, green jobs, and maritime. In 2020, the Economic Recovery Program was established to help communities recover from the devastating economic impacts of the COVID-19 pandemic. In 2025, through community listening sessions, partner feedback, and utilization of the [Equity](#)

[Index](#), the Economic Recovery Program evolved into the EOC Program, refocusing funds to advance economic opportunity instead of recovery.

In 2024, the Port of Seattle Commission [authorized \\$14 million](#) over the next five years to continue SKCCIF community-led projects that advance equity, environmental improvements, and access to jobs and careers in port-related industries.

“This opportunity creates access to Port funds for communities facing environmental and economic disparities, many of whom have never received funding support from us before,” said Port of Seattle Commission President Toshiko Hasegawa. “\$14 million is an unprecedented direct investment into communities closest to the issues and leading on solutions.”

SKCCIF is an incredible example of an effective public-private partnership. Over the last five years, the program has strengthened the Port’s relationships with many organizations and communities we serve. In the next five years, we are excited about the new and continued partnerships and community investments. [Partner with your Port](#) and invest in your community.
