

NOTICE OF PUBLIC HEARING

Notice is hereby given that a designated representative of the Port of Seattle (the “Port”) will hold an open public hearing on Thursday, June 11, 2026, starting at approximately 9:00 a.m. to be conducted via telephone conference call to consider a plan of finance consisting of one or more series of obligations (which may include refunding obligations) (the “Bonds”) to be issued by the Port. The Bonds will include exempt facility bonds to finance or refinance airport facilities (the “Projects”) under Section 142(a)(1) of the Internal Revenue Code of 1986, as amended (the “Code”). This public hearing is being held as required by Section 147(f) of the Code.

The Projects will be owned by the Port and located at or adjacent to Seattle Tacoma International Airport (“Airport”) at 17801 International Boulevard South, SeaTac, WA 98158, owned by the Port. The maximum amount of exempt facility bonds expected to be issued for the Projects is \$720,000,000.
