Unlawful Discrimination

It is unlawful for airport and maritime operators and their lessees, tenants, concessionaires and contractors to discriminate against any person because of race, color, national origin, sex, creed, or disability in public facilities, services and employment opportunities. Allegations of discrimination should be promptly reported using one of the methods below:
